

TERMS AND CONDITIONS – CAHL/CWAHL WINTER 2019-20: CAHL.HOCKEY

1. CAHL teams will play 25 guaranteed games including playoffs.

2. CAHL/CWAHL Payment Schedule

1st payment:	\$500.00 deposit due August 9th, 2019
2nd payment:	\$2785.00 dated September 15th, 2019
3rd payment:	\$2785.00 dated October 15th, 2019
Total:	\$6,070.00

- The CAHL accepts cheques, Visa and MasterCard as forms of payment.
- Credit card payment instructions will be sent out to teams upon acceptance into the league.
- To update method of payment contact Joshua.Shaw@carleton.ca at least 2 weeks prior to payment date
- Failure to provide payment will result in a forfeited game. Failure to provide payment before the 1st game of the season will result in team removal from the CAHL.
- No 'third party' cheques will be accepted. All cheques returned NSF, will result in a \$50.00 service charge.
- Due to security reasons, please do not send payment information via email.

3. Final selection of teams for entry into the CAHL/CWAHL will be at the discretion of the CAHL Directors and/or the CAHL Convener.

4. The [CARHA Official Rule Book](#) will apply unless otherwise stipulated in the [CAHL Rules](#).

5. Schedule Update Policy

- 1) If we receive an e-mail from team requesting move 10+ business days from the scheduled game, we will contact the teams involved and propose a schedule,
- 2) We will repeat step 1 once more in order to find a game to switch with.
- 3) If there is a late hour of open ice we will propose to move the game there.
- 4) If there is no resolution, the team is expected to find spares for the game.
- 5) If a team simply must cancel the game, we will attempt to schedule an exhibition game with another team and award the opponent a 1-0 win.
- 6) If a team no-shows or we are unable to complete step 5 then we will charge the \$150 forfeit fee to the team who defaulted.
- 7) If teams request a reschedule inside of 10 business days, we will jump immediately to step 5.

8) Any same day requests for a reschedule will be charged \$150 forfeit fee.

6. Schedule Requests

We will circulate a form at the beginning of the season asking teams to indicate dates that they will not be available to play. Any requests that are not listed are not guaranteed to be accommodated. Teams are expected to find spares for games that are unable to be moved per the above schedule update policy.

7. Team Roster

An email will be sent to team reps with instructions to submit roster and complete waivers at least 2 weeks prior to season start. Rosters are insured for a maximum of up to 18 players, including spares and goalies.

8. League Withdrawal Policy

- a. Should a team withdraw after the season has started, the \$500 deposit will not be refunded.
- b. The refunded amount will be determined by the number of games played and charged at \$250/game played. This applies only to the first 5 games of the season. From the 6th game onwards, teams must pay the full amount.
