

TERMS AND CONDITIONS – CAHL/CWAHL SUMMER 2019: CAHL.HOCKEY

Teams who take part in the league agree to the following:

1. CAHL teams will play 19 games including playoffs. CWAHL teams will play 18 games including playoffs.
2. The full team fee to play in the CAHL/CWAHL Summer 2019 Hockey Season is CAHL, \$4500.00 and for CWAHL, \$4400.00.
Balance of team entry fee, after receipt of the \$500.00 deposit (dated April 1st, 2019), will be due in two (2) payments made payable to Carleton University Athletics – CAHL and MUST ACCOMPANY THIS AGREEMENT.

CAHL Payment Schedule

1st payment:	\$500.00 deposit due April 1 st , 2019
2nd payment:	\$2000.00 dated May 15 th , 2019
3rd payment:	\$2000.00 dated June 15th, 2019
Total:	\$4,500.00

CWAHL Payment Schedule

1st payment:	\$500.00 deposit due April 1 st , 2019
2nd payment:	\$1950.00 dated May 15 th , 2019
3rd payment:	\$1950.00 dated June 15th, 2019
Total:	\$4,400.00

- The CAHL accepts cheques, Visa and MasterCard as forms of payment.
- Credit card payment instructions will be sent out to teams upon acceptance into the league.
- To update method of payment contact Joshua.Shaw@carleton.ca at least 2 weeks prior to payment date
- Failure to provide payment will result in a forfeited game. Failure to provide payment before the 1st game of the season will result in team removal from the CAHL.
- No 'third party' cheques will be accepted.
- Due to security reasons, please do not send payment information via email.

3. Team also agrees to, and include, a \$200.00 Team Bond, (cheque or credit card authorization) to be dated April 1st, 2019), to be applied towards any fines or charges (ie. Cancelled/NSF cheques, forfeits, property damages, penalty fines, player or team disciplinary issues...) that the team may be assessed during the season.

4. All cheques returned NSF, will result in a \$50.00 service charge added onto replacement cheque/cash, or may be taken from Team Bond.
5. Any regularly scheduled and/or playoff games that cannot be played at scheduled date and time because of University commitments to other clients and/or for unforeseen problems will be rescheduled for the first available date and time, and in case of playoffs, only if necessary.
6. SWEATERS. ALL players on all teams MUST wear IDENTICAL colored sweaters. Teams are required to have two set of sweaters. See Rules and Regulations. Home teams will wear their primary jerseys and away teams will change in the event of a color conflict.
7. ALL helmets and goalie masks MUST be CSA approved with NO missing or broken parts and MUST have a proper chin strap (no tape). If a player is seen on the ice with a helmet that no longer conforms with this article's first sentence, will receive an 'illegal equipment' minor penalty and will not be permitted to return to the ice until it is corrected or replaced. Helmet violations will be called by referees who may have been informed by a timekeeper or supervisor. **Goalies please note that "Cat Eye" Goalie masks are permitted only with a signed CARHA waiver which waives facial protection. Waiver is available upon request.**
8. Final selection of teams for entry into the CAHL/CWAHL will be at the discretion of the CAHL Directors and/or the CAHL Convener.
9. No team in the CAHL may use a 'carded' player who is playing in any junior league, or better caliber. Semi-professional players are permitted.
10. I have read and understand the CAHL's Terms and Conditions. I also agree to inform all my team's players of all CAHL's Terms and Conditions.
11. I/We agree that our team, or any player on our team, may be ejected from the CAHL for "just cause" (displaying a continual lack of respect to opposing players and either referees or CAHL officials, intent to injure anyone, etc.) without any reimbursement of CAHL fees given to that point.

12. **Schedule Update Policy**

- 1) If we receive an e-mail from team requesting move 10+ business days from the scheduled game, we will contact the teams involved and propose a schedule,
- 2) We will repeat step 1 once more in order to find a game to switch with.
- 3) If there is a late hour of open ice we will propose to move the game there.
- 4) If there is no resolution, the team is expected to find spares for the game.
- 5) If a team simply must cancel the game, we will attempt to schedule an exhibition game with another team and award the opponent a 1-0 win.
- 6) If a team no-shows or we are unable to complete step 5 then we will charge the \$150 forfeit fee to the team who defaulted.
- 7) If teams request a reschedule inside of 10 business days, we will jump immediately to step 5.
- 8) Any same day requests for a reschedule will be charged \$150 forfeit fee.

13. **Schedule Requests:** We will circulate a form at the beginning of the season asking teams to indicate dates that they will not be available to play. Any requests that aren't listed can't be guaranteed to be accommodated. Teams are expected to find spares for games that can't be moved per the above schedule update policy.

14. Team Roster

All team members must complete the Online Roster and Waiver Registration section of the website. An email will be sent to team reps with instructions at least 2 weeks prior to season start. Rosters are insured for a maximum of up to 18 players, including spares.

15. League Withdrawal Policy

- a. Should a team withdraw after the season has started, the \$500 deposit will not be refunded.
- b. The refunded amount will be determined by the number of games played and charged at \$250/game played. This applies only to the first 5 games of the season. From the 6th game onwards, teams must pay the full amount.

16. Please review League Terms and Conditions. By submitting application, teams acknowledge and agree to these terms.
